## 4 TERMS AND CONDITIONS

**1. Commercial Item Determination** All products and services listed in this schedule are asserted as "Commercial Items" pursuant to **41 U.S.C. § 103** and **FAR Part 12**.

### 2. License Scope & Restrictions

- **Subscription Licenses (SKUs ending in -001):** Grant the customer "Restricted Rights" (as defined in DFARS 252.227-7014) to use, deploy, and copy the compiled software for Government purposes only. Ownership of source code, trade secrets, and background IP remains exclusively with Strategi Consulting.
- **Perpetual Transfer (SKU -SRC-GPR):** Includes a one-time transfer of a "Perpetual, Non-Exclusive Source Code License" to the specific software version active at the time of purchase. This license permits modification and integration for U.S. Government purposes but strictly prohibits commercial resale, distribution to non-Government entities, or re-licensing without Strategi's written consent.

### 3. Warranty & Support

- **Standard Support:** Subscription licenses include standard break/fix support, security patching, and binary updates for the duration of the term.
- **Enhancements:** Requests for new feature development or custom integration are not included in the base license and must be funded via a separate Professional Services Task Order using the rates in **Table 2**.

### 4. Payment Terms

### 5. Deployment & Hosting Options

The Enterprise Subscription fees listed herein cover the software license rights and standard support only. Customers may choose between two deployment models at the same license price:

- **Option A: Customer-Hosted (GovCloud/On-Prem):** The Customer provides the infrastructure (e.g., AWS GovCloud, Azure, or Hardware). Strategi provides the deployment artifacts (containers/binaries). No additional hosting fees apply.
- **Option B: Strategi-Hosted (SaaS):** Strategi provisions and manages the cloud environment. Cloud infrastructure costs (compute, storage, egress, token usage)

are invoiced monthly in arrears based on actual consumption (Pass-Through) or as a negotiated Firm Fixed Price (FFP) tier (See SKU **VOL-INF-SAAS**).

Labor required to deploy and configure solution to customer environments will be charged as incurred using rates outlined in the professional services schedule.
